Corrille for the following debts or sums of money to wit the sum of seven hundred and forty five dollars and cents due to John Thompson and James Rockwell sons of John Rockwell also by Specialty bearing date the 2nd of January 1820 the sum of one thousand three hundred and twenty dollars and sixty cents due Thomas Peckham by note bearing date the 24th day of August one thousand eight hundred and nineteen the sum of five hundred and ninety seven dollars and thirty one cents bearing date the twenty first of December 1818 due by Note to Martin Harris the sum of four hundred and eighty five dollars and eighty cents to be discharged by the payment of two hundred and forty three dollars and four cents due by fourth coming and delivery Bond bearing date the fourth day of November 1820 to Simon Murphree for the benefit of Henry D. Vaughan the sum of nine hundred and ninety two dollars and eighty eight cents to be discharged by the payment of four hundred and ninety six dollars and forty four cents due to Williamth Rappelle for the benefit of Peter Mason by fourth coming or delivery Bond bearing date the 1st day of November 1820 the sum of thirteen hundred and ninety one dollars & twenty two cents to be discharged by the payment of ten hundred and ninety five dollars and sixty one cents to John Gordon and William Clark late Merchants and partners trading under the firm & style of John Gordon & Co. by fourth coming or delivery bond bearing date the 1st day of November 1820 the sum of nine hundred & seventeen dollars and sixty two cents to be discharged by the payment of four hundred and fifty eight dollars and thirty one cents due to Thomas Lammes and John F. Lammes merchants and partners trading under the firm and style of J & F Lammes by fourth coming or delivery Bond bearing date the 1st day of November 1820 the sum of two hundred and eighty dollars and fourteen cents due by Specialty made payable to James Jackson Esq^r of James Milkensons due bearing date the 22nd day of April 1820 which has since been transferred or assigned to Calvin W. Barnes the sum of five hundred dollars due to Messrs Mordburn & Co of James Jackson Esq^r of James Milkenson by Specialty bearing date the 20th day of November 1819 also the sum of three hundred dollars due to James Jackson Esq^r of James Milkenson due by Specialty bearing date the 24th day of November 1819 also the sum of thirteen hundred and thirty four dollars and thirty cents to be discharged by the payment of six hundred and seventy seven dollars and thirty five cents due to Alexander and Richard M. Cunningham merchants & partners trading under the firm and style of A & R M Cunningham
