This Indenture made this 20th day of November in the year of our Lord which
 was thousand eight hundred and twenty one between Thomas & Brock and Polly Brock his wife
 both of the County of Southampton and State of Virginia and Elsie Lewis his wife
 and part and Elsie Lewis of the same County State and Parish of Baltimore of the
 Midship that the said Thomas, Brock and Polly his wife for and in consideration
 of the sum of fifty dollars current money of Virginia to them in hand paid
 by the said Elsie Lewis the receipt whereof the said Thomas Lewis & Brock and Polly
 his wife doth acknowledge themselves fully and amply satisfied and have both granted
 bargain and sell enfeoffed and even unto the said Elsie Lewis to have and to his heirs
 forever one certain tract or parcel of land and premises situate lying and being
 in the County State and Parish aforesaid bying adjoining the said Elsie Lewis
 and bounded as follows To wit Beginning at a black gum standing in the
 Horsehoe Branch Cr. of Reddy Drake thence at 12 E 16 Pole thence at 14 E 16 pole
 to a pine Cr. of Elsie Lewis at his farm thence at 58 N 82 pole to a pine a corner
 Thomas Pethers line thence along his line 168 N 20 pole to a red oak a new corner
 made between Thomas & Brock and Elsie Lewis thence S 55 E along a straight
 line of new markers two to a Pine tree a new corner in the Horsehoe Branch
 and in Reddy Drake's line thence up the run of said Branch to the first station
 containing twenty acres ^{to the run} more or less together with all houses and houses appurtenances
 buildings yards gardens orchards ways roads and water courses whatsoever belonging
 or in any wise appertaining to the the said tract or parcel of land and to have
 the same unto the said Elsie Lewis to him and to his heirs forever and that
 Thomas & Brock and Polly his wife for themselves then their Executors
 assigns doth by these presents warrant and forever defend all right title claim
 or demand of any Person or Persons claiming or demanding the same or any
 part or parts thereof In witness whereof the said Thomas & Brock and
 Polly his wife hath hereunto set their hands and affixed their seals this day
