This Indenture made this 7<sup>th</sup> day of December one thousand eight hundred  
and twenty one between Rhoda McHenry of Southampton County of the one part  
and Matthew Foster of the same County of the other part Witnesseth that the said  
Rhoda McHenry for and in consideration of eighteen dollars yearly rent of land  
a kind of the plantation which the said Matthew Foster now lives to be paid  
to the said Rhoda McHenry by the said Matthew Foster at the expiration of  
every year which the said Foster is hereby bound to perform both by his present  
diminished granted farmed lot and leased unto the said Foster with  
the said land and plantation and all the advantages as there mentioned  
the said Foster is proper for and during five years and no longer than to  
rent to the said McHenry or to whom she may deem the said Foster  
giving and paying to the said McHenry or the assigns the yearly rent above
