Mouffe of the first part and Simon Souper of the second part. Witnesseth that whereas the said
Thomas D Heath and Samuel Mouffe hath granted bargained and sold for the sum
of fifty one dollars unto the said Simon Souper the Acre of Land in the Town
of Abner which said Land was sold unto Thomas R Collier by Clement
Rochester and afterwards conveyed to the said Heath and appears by
deed recorded in the clerks office in Southampton County and appears
on Map of said town as Lots No. 16, 17, 34 and 39 all of which
was offered by the deed executed by Rochester and wife to the said
R Collier the receipt whereof is hereby acknowledged and the said Thomas
D Heath do by these presents warrant the said Lots of Land to have the said
Simon Souper his heirs and assigns forever also the above named Samuel Mouffe
hath granted bargained and sold for the just and full sum of fifteen dollars
Lawful money of Virginia the receipt whereof is hereby acknowledged on
acre of Land by and being in the town of Abner to the above named
Simon Souper which said Land was sold by the above named Clement
Rochester to the said Samuel Mouffe which appears in the map of Abner
as Lots No. 40 and 50 and is by these presents warrant and wife
forever defend the right and title of said Land or Lots of Land to
have the said Simon Souper his heirs and assigns forever to the intent
whereof we the above named Thomas D Heath and Samuel Mouffe
hath set our hands and seals this day and date first before written

and twenty two between Shadrach Deal and Anne Deal his wife of the county of Southampton and state
of Virginia of the one part and Abner Deal of the same county and state of the other part. Witnesseth
that the said Shadrach Deal and Anne his wife for and in consideration of the just and
full sum of one hundred and nine dollars and seventy four cents current money of the United
States by the said Abner Deal to them in hand paid the receipt whereof is hereby acknowledged
and thereof acquit and discharge the said Abner Deal his heirs and assigns forever
and themselves their heirs fully and truly satisfy and contented and paid the said Shadrach
Deal and Anne his wife have granted bargained sold aliened conveyed released set
over delivered and confirmed and by these presents do grant bargain sell alien
convey release set over deliver and confirm unto the said Abner Deal and to
his heirs and assigns forever a certain part of that plantation tract or parcel
of Land wherein the said Shadrach Deal and Anne his wife now lies
situate in the County of Southampton aforesaid containing by estimation
twenty five acres in the same more or less and bounded as follows
