This Indenture made this eighteenth day of March one thousand eight hundred and forty two between Samuel Peale of the county of Southampton and state of Virginia of the first part James Scott of the same County and state of the second part and Joseph Pritton of the County of Southampton and state of Virginia aforesaid of the third part witnesseth that whereas the said James Scott stands pretty matched by a note of hand to the said James Scott in the sum of one hundred and seventeen dollars and thirty one cents current money of the United States of America and whereas for the further assurance of the payment of the payment of the same is agreed by the parties hereto that a conveyance in trust shall be made to the said Joseph Pritton for the benefit of the said James Scott of the sum or the note of hand aforesaid shall not be punctually paid with Lawfull interest thereon on or before the first day of September next year this Indenture witnesseth that the said Samuel Peale for and consideration of the premises and for the further consideration of one dollar to him in hand paid the receipt of which is acknowledged his bargains and sold and by these presents doth for himself his heirs Executors and administrators grant bargains and sell unto the said Joseph Pritton his heirs and assigns all that plantation tract and parcel of Land which the said Samuel Peale bought of Shadrach Peale also Anne his wife by Indenture bearing date equal with this present Indenture containing by estimation fifty acres be the same more or less bounded as by the aforesaid Indenture from Shadrach Peale and Anne his wife to the aforesaid Samuel Peale is described especially being thereas had with ~~under~~ fully made it appear and also all the buildings woods ways waters advantages and appurtenances to the same belonging or in any wise appertaining to the aforesaid remains rents spous and profits thereof and all the estate right title of him the said Samuel Peale of or and to the same to have and to hold the above granted and bargained premises with every of the appurtenances unto the said Joseph Pritton his heirs and assigns in trust forever and it is hereby declared to be the true intent and meaning of these presents that if the said Samuel Peale shall punctually pay to the said James Scott his heirs or assigns the said sum of One hundred and seventeen dollars and thirty one cents and interest agreeable to the time of the note of hand to the said James Scott then the said Joseph Pritton his heirs and assigns shall hold the said tract of Land above granted to the sole and proper use and behoof of the said Samuel Peale and the said Joseph Pritton concurrent and agree with the parties hereto that if the said Samuel Peale his heirs Executors and administrators shall fail to make payment to the said James Scott his heirs and assigns on or before the 1<sup>st</sup> day of November next the sum due on the note of Land aforesaid that then the said Joseph Pritton his heirs and assigns shall stand seized of the aforesaid granted and bargained premises for the purpose following that is to say that at the request of the said James Scott his heirs and assigns he the said Joseph Pritton his heirs Executors and assigns or either of them
