Hart in hand paid by the said Willis Mmble at an before the sealing and delivery of these presents the receipt whereof is hereby acknowledged by the said Eamun B. Hart hath given granted bargained sold aliened enfeoffed released and confirmed and by these presents doth give grant bargain and sell alien enfeoff released and confirm to the said Willis Mmble his heirs and assigns forever all the tract or parcel of Land lying and being in the County of Southampton State of Virginia containing seven hundred and seventy two acres be the same more or less and bounded as follows to wit southwesterly by the State line of North Carolina northwesterly by the Lands belonging to the estate of John W. Williams decd Northwesterly by the Lands of Matthias Williams and northwesterly by the Lands of William Wren and Nathaniel D. Land with all the singular the appurtenances to the said tract or parcel of Land belonging or in any way appurtenant and also the estate right title and interest
