This Indenture made this 5th day of December in the year of our Lord
 one thousand eight hundred and twenty one between Thomas Ford of the
 first part Timothy Sykes of the second part and Harrison Stephenson adm-
 inistrator of Temperance Turners dec'd of the third part all of the County of
 Southampton and State of Virginia Whereas the said Timothy Sykes on
 the 8th day of November in the Year of our Lord one thousand eight hundred
 and twenty in order to secure the payment of One hundred and thirty
 dollars and seventy cents to the said Harrison Stephenson Dec'd by Indenture
 of Trust of that date Conveyed to the said Thomas Ford his heirs Executors &c
 the said land &c property to wit one certain tract or parcel of Land containing
 by estimation seventy two acres to the same more or less and bounded by the
 lands of Robert Mercer William Bonden and Robert Adams upon Trust
 for the uses and purposes in the said Indenture mentioned and whereas
 from the executing and delivering of the said dec'd in Trust the said
 Timothy Sykes hath fully satisfied and paid to the said Harrison Stephenson
 the sum of money thereby secured which the said Harrison Stephenson
 doth hereby acknowledge. Now This Indenture witnesseth for the Com-
 munion of said as well as for the further consideration appraised dollar
 in hand paid by the said Timothy Sykes to the said Thomas Ford at an
 before the signing and delivery of these presents the receipt whereof
 is hereby acknowledged by the said Thomas Ford with the agent and
 approbation of the said Harrison Stephenson signified by his being parties
 to these presents and the said Harrison Stephenson have granted, sold
 and sold remise released and Confirmed and by these presents
 do grant bargain and sell now release & confirm
