This Indenture made this 15th day of January in the year of our Lord one thousand
 eight hundred and twenty two between John Crumpler of the one part Herod Hummel
 of the other part both of the County of Southampton and State of Virginia Witnesseth
 that the said John Crumpler for and in consideration of the sum of five hundred 12 dollars
 to him in hand paid before the sealing and delivery of these presents the receipt
 whereof I the said I the said John Crumpler doth hereby acknowledge
 have granted bargained and sold alien released and confirmed and by these
 presents doth grant bargain and sell alien release and confirm unto the said
 Herod Hummel his heirs and assigns forever one certain tract or parcel
 of Land situate lying and being in the County of Southampton containing by
 estimation one hundred acres be the same more or less and bounded as follows
 To wit Beginning at a pine a corner tree of George Lewis and Samuel
 Stephenson line from thence a line of marked trees to a pine standing at
 the head of a dam branch dividing line of George Lewis to down said branch
 to the mouth of said branch dividing line of Robert Hart to down the said
 branch to the mouth of the dam branch dividing line of Benjamin Crumpler
 to up said branch to a pine at the head of the branch to a line of marked
 trees to the head of a branch down the said branch to a pine a corner tree
 Benjamin Crumpler and Henry Partridge line to a line of marked trees
 to a branch a line of Lucy Brock up said branch to a pine a corner tree
 of Samuel Stephenson line to a line of marked trees to the fork Station
 to have and to hold unto the said Herod Hummel his heirs and assigns
 forever and also the remainder and remainders reversion and reversions and
 issues and profits of the said tract or parcel of Land to the only proper use
 and behoof of him the said Herod Hummel his heirs and assigns forever
 and the said John Crumpler for himself his heirs and assigns doth warrant
 and agree to and with the said Herod Hummel his heirs and
 assigns forever that he the said John Crumpler the last part of the
 six samples of the said Land with warrant and forever assigns unto him
