This Indenture made this 28<sup>th</sup> day of January eighteen hundred and twenty  
between Samuel Daughtery and Polly his wife of Southampton County and State of  
Virginia of the one part and Abnerath Holland of Southampton County and State of  
Virginia of the other part witnesseth that the said Samuel Daughtery and  
Polly his wife for and in consideration of the sum of Eleven hundred and forty five  
dollars current money of Virginia to them in hand paid the receipt whereof the  
said Samuel Daughtery and Polly his wife doth hereby acknowledge that  
Samuel Daughtery and Polly his wife have granted bargained sold aliened  
and confirmed unto the said Abnerath Holland his heirs and assigns  
forever a certain tract or parcel of Land lying in the County of Southampton  
and bounded as follows to wit. Beginning at large pine a corner tree of  
Richard Murrel then south forty seven degrees west thirty six poles to a small  
branch thence the various courses of the said branch to a pine leaving the  
said pine in Sopar Vaughans line thence north twenty three degrees west thirty  
six poles to an oak in the said Vaughans line then south eighty seven  
degrees west thirty six poles to a white oak a corner tree of Gordon Vaughn  
are standing on the side of a small branch then the various courses of  
the said branch to a black gum standing in the run of the Gordon  
then the various courses of the Gordon Run to a small tract gum a  
corner of Joseph J. Hollands then south forty two degrees east forty  
poles to a large white oak a corner tree of Samuel Daughtery and Joseph  
Hollands then north seventy four degrees east eighty poles to a pine in  
Carveras line then south three degrees east twenty four and then south side  
to a red oak at the Fork of the road then a straight line of (marked)  
trees to the first station containing by a late survey two hundred and twenty  
nine acres be the same more or less together with all reversions Remainders  
rents profits services and emoluments of the said Land and premises and  
every part and parcel thereof to have and to hold the said Land and  
premises with the appurtenances unto the said Abnerath Holland his  
heirs and assigns forever and the said Samuel Daughtery & Polly  
his wife for themselves then heirs to the said Land and premises and every part  
or parcel thereof and against all and every other person or persons their  
heirs to the said Abnerath Hollands his heirs or assigns forever and  
the said Samuel Daughtery and Polly his wife for themselves then  
heirs to. Shall and will warrant and forever defend the said  
Land and premises unto the said Abnerath Hollands his heirs and  
assigns forever from all manner of persons laying any claim  
thereunto In witness whereof the said Samuel Daughtery and  
Polly his wife hath put their hands and affixed their seals the  
day and year above written signed sealed and delivered
