This Indenture made and entered into on this twenty fifth day July in the year of our Lord one thousand eight hundred and twenty two by and between William Burgason Jr of the first part Benjamin Barnes of the second part and Jacob Barnes of the third part all parties hereto of the County of Southampton in the State of Virginia. This Indenture witnesseth that said William Burgason Jr is freely indebted to the above named Jacob Barnes in the sum of two hundred & Eighty five dollars by bond of even date with this Indenture payable on demand the payment of which together with the interest which shall arise thereon the said William Burgason are willing and desirous effectually to discharge to the said Jacob Barnes. Wherefore this Indenture witnesseth that the said William Burgason as well in consideration of the premises as of the sum of one dollar current money of the United States to him in hand paid by the said Benjamin Barnes at and before the concluding and delivery of these presents the full receipt whereof is hereby acknowledged and from every part of which the said Benjamin Barnes and all his legal representatives are fully released exonerated and discharged. Have granted bargained and sold and do hereby grant bargain & sell unto the said Benjamin Barnes his heirs and assigns for solemnthatas to say the said William Burgason have granted bargained and sold and do hereby grant bargain and sell unto the said Benjamin Barnes his heirs and assigns on certain tract or parcel of land containing severn acres in the same more or less and bounded by the lands of the following named persons to wit - Lewis Morell William Allen John Bargards and also the land wherein John Routs now lies so here and to hold the said tract or parcel of land and all and singularly the appurtenances thereto in any manner belonging and all the right title in trust Estate whatsoever of him the said William Burgason of or as to the same to him the said Benjamin Barnes his heirs Execr admt and assigns forever to the only proper use and behoof of him the said Benjamin Barnes his Execr admt and assigns forever. I further witnesseth that if the said William Burgason his heirs Execr admt shall well and truly pay to the said Jacob Barnes Execr admt or assigns the aforesaid sum of two hundred and eighty five dollars with the interest which shall accrue thereon on or before the said Jacob Barnes his heirs Execr admt administrators shall or may require the same that then this Indenture and every thing herein contained is to be void and of none effect but if the said William Burgason his heirs Execr admt shall or does not pay the aforesaid sum of two hundred and eighty five dollars with the interest which shall have accrued thereto on or before the time the said Jacob Barnes his heirs Execr admt may or shall require the same then upon the request in writing either of the said Jacob Barnes his Execr admt or assigns or of the said William Burgason his heirs Execr admt the said Benjamin Barnes shall and may sell and dispose of the said tract or parcel of Land out of the money raised thereon pay and satisfy the said debt interest rate at 6
