This Indenture made and entered into on this 24th day of July in the year of our Lord
one thousand eight hundred and twenty two by and between Benjamin Barnes John Kauls
and Sabitha Kauls wife of the said John Kauls of the County of Southampton in the State
of Virginia of the one part and William Surgason of said County and State of the other part
Witnesseth that whereas the said Benjamin Barnes by virtue of a deed executed to him by the
said John Kauls dated June 1717 did on the 20th day of July 1722 in discharge of duty impos-
ed on him by the trust to him committed sell seventy five acres of Land which the said
John Kauls conveyed by said deed to the said Benjamin Barnes in trust as aforesaid
which the said William Surgason purchased for the sum of two hundred dollars and for
the further sum of one hundred and eighty five dollars in hand paid to the said John
Kauls and Sabitha Kauls his wife by the said William Surgason and also before the
executing and delivery of these presents the receipt whereof he duly acknowledged have granted
bargained and sold and do by these presents grant bargain and sell unto the said William
Surgason his heirs and assigns all the right title interest and estate which he the three first
above named have in and to the said seventy five acres of Land as aforesaid and also the
said John Kauls and Sabitha his wife do in consideration of the aforesaid sum of one hund-
red and eighty five dollars paid as aforesaid bargain and sell unto the said William Sur-
gason two acres of Land adjoining the said seventy five acres of Land which two acres of
Land the said John Kauls purchased of William Story each of two tracts or Lots of Land
lying and being in the County of Southampton and bounded by the following named persons land
to wit the said John Kauls when he the said John Kauls now lives Lewis Womble William Elliott John
Wargrave the whole number of acres conveyed hereby being seventy seven acres agreeable to late survey
by the surveyors or left together with every advantage profit and interest to the said Land
belonging or in any way or manner appertaining unto him the said William Surgason
and his heirs and assigns forever To have and to hold the said seventy five acres of Land and the
said two acres of Land unto every part thereof unto the said William Surgason his heirs and
assigns forever to and for the only proper use and behoof of him the said William Surgason
his heirs and assigns forever and the said Benjamin Barnes trust for himself and his heirs
the said seventy five acres of Land with all its profits unto the said William Surgason
his heirs and assigns free from the claim of him the said Benjamin Barnes twice his heirs
and the said John Kauls and Sabitha his wife for themselves and their heirs the said seventy five acres
of Land also the said two acres of Land adjoining the same as aforesaid with all their appurtenances
unto the said William Surgason his heirs and assigns free from the claims or claims of them the
said John Kauls and Sabitha his wife or either of them their or either of their heirs and of all and
every person or persons whatsoever and the said Benjamin Barnes trustee shall well and lawfully defend
and forever defend against every claim of himself and his heirs only but the said John Kauls
and Sabitha his wife shall well and lawfully defend and forever defend by these presents a peaceable &
uninterrupted title in fee simple to the two lots or tracts of Land as aforesaid In witness whereof
the said parties have hereunto set their hands and affixed their seals the day and year first herein written
