This Indenture made the 21st day of September in the year of our Lord 1722 between James Bishop and
 Abson Bishop of the County of Southampton of the one part and Samuel Drake of the other part all of the County of Southam-
 pton and state of Virginia Whereas that the said Samuel Drake by his deed dated the 22nd day of August 1720
 and admitted to record in the Clerks office of the County Court of Southampton on the 19th day of February 1721 in order to
 secure the payment at the time specified of the sum of five hundred and twenty dollars and seventy five cents (and
 and payable the 21st of July 1721) owing by him the said Samuel Drake to the said James Bishop and
 eyed in trust to the said Abson Bishop all his the said Samuel Drake right title claim interest &
 demand that he has in or on the Lands the father Samuel Drake was seignior and proprietor of at the time
 of his death and the said sum of five hundred and twenty three dollars and seventy five cents with all
 interest accruing thereon and also all costs and charges attending the same having been fully paid by the
 said Samuel Drake he requested that the Estates Comd by the said day of trust to whom the said James Bishop
 and Abson Bishop in this said Land came to succeed & have the said Samuel Drake This Indenture therefore

 and delivery of these presents the acceptance of is hereby acknowledged by the said James Bishop &
 Abson Bishop with the consent of the said James Bishop & approved by his being a party hereto hee grants
 remises release and forever quit claim and by these presents do fully and absolutely grant
 remises release and forever quit claim unto the said Samuel Drake his heirs and assigns forever all the
 Estates right title interest property claim and demand whatsoever in Law or
 equity of them and each of them the said James Bishop and Abson Bishop of us and to the
 aforesaid Lands and in appurtenances to have and to hold the aforesaid Lands with etc
 appurtenances to the said Samuel Drake his heirs and assigns to the only use & behoof
