This Indenture made the 22 day of October the year of Our Lord one thousand eight hundred and twenty two between Jacob Williams of the County of Southampton of the one part and Nathan Pope of the said County of Southampton part Whitchfield that the said Jacob Williams for and consideration of the sum of the sumers and dues the said amount owing of one hundred and ten pounds by the said Nathan Pope in hand paid the receipt whereof of the said Jacob Williams doth hereby acknowledge hath granted bargained sold and conveys unto these presents with grant long and short and come up to the said Nathan Pope his heirs and assigns a certain tract or parcel of Land containing fifty two acres to the same more or less lying and being in the County of Southampton and known by the name of the said bounded to as follows to wit beginning at a small rock or a run corner made between Jacob Williams and Thomas D'Knight and on Nathan Pope's boundary line thence along Nathan Pope's line S 70° E 58 poles to a post to a fence a corner of Nathan Pope's land and on the side of a small branch thence North W 10° E 50 poles to a post to a junction on the line thence N 17° W 50 poles to a small hickey & run corner made between Jacob Williams and Thomas D'Knight and on John Eggleston's land thence S 70° E 58 poles to a post to a spallish or a run corner made between Jacob Williams & Thomas D'Knight thence along the dividing line of the said parties S 28° E 112 poles to the first station containing fifty five acres be the same more or less to hold the said tract or parcel of Land with the appurtenances thereto belonging to him the said Nathan Pope his heirs or assigns to the only proper use and behoof of the said Nathan Pope his heirs and assigns forever and the said Jacob Williams forsooth by his Test and Administration doth hereby covenant and agree to and with the said Nathan Pope his heirs and assigns that the said Jacob Williams and his heirs the said tract or parcel of Land with its appurtenances unto him the said Nathan Pope his heirs and assigns against him the said Jacob Williams and his heirs & against all persons wheresover shall be so writing or any of the said Jacob Williams hath hereto set his hand and affixed the seal the day and year above written
