four hundred dollars current money of Virginia to be paid by the said Jordan Symer to them
in hand at or before the ensaing and delivery of these presents the receipt whereof the said
Amos Dyer and Stacey Dyer his wife doth fully acknowledge and therefore acquit &
discharge the said Jordan Symer his heirs and assigns forever and themselves therewith
fully and entirely satisfied contented and paid have granted bargained sold alredy
executed and confirmed and by these presents do grant bargain sell all and
release set over deliver and conform unto him the said Jordan Symer one to the said
and assigns forever all that plantation messuage tract and parcel of Land wherein the
