paid by the said Thomas Stow therewith whereof the said Sally Francis doth hereby acknowledge she
said Sally Francis doth bargain sell also and Conferm by these presents to the grantor the said
and Confirm unto the said Thomas Stow his heirs and assigns forever on certain tract or parcel of
Land Containing by late survey two hundred and forty acres to be the same more or less of being part of the
Land formerly belonging to Samuel Francis deceased and drawn by William Francis and being
lot No 3 for which the Commemories object or used will fully show the boundaries together with all and
singular the rights members and appurtenances therunto belonging and the revision and reasessing
spes and profits thereof to have and to hold the said tract or parcel of land and all and singular
the premises hereby bargained and sold or mentioned to be unto her and every of her
right members and assigns to be the only purpose of the said Thomas Stow and his heirs forever and
the said Sally Francis her heirs will warrant and forever defend the premises aforesaid unto the said
Thomas Stow his heirs and assigns forever against all and every person or persons whatsoever

This Indenture made this 1st day of November one thousand Eight hundred and twenty two between Eun Bryant of the
County of Southampton of one part and Eliza Bryant of the other part witnesseth that the said Eun
Bryant for and consideration of the sum of One hundred dollars to her in hand paid by the said Eliza Bryant the
receipt whereof is hereby acknowledged both bargained sold and Confermed unto the said Eliza Bryant and to her heirs forever
on tract or parcel of Land lying in the County of Southampton forward and in the parish of Saint Lukes containing by Estimation
Tin acres and bounded as follows Beginning at a black gun standing on the rear of a small branch a few rods from said
Eliza Bryant on said Eun Bryant's line thence along said Eun Bryant's line to a corner on said Branch line then
a few rods aft said gun standing on the side of the Path a sum corner of Eun Bryant's line along the said
Branch line to the rear of a small branch thence down the various courses of the said branch to a black
gun standing at the intersection of the two branches nor corer of Eun Bryant and Eliza Bryant's line and on said said
Branch line thence along said Eun Bryant's line up the various courses of the first branch to the beginning all
the right title &c of an acre to the said Land and plantation from the said Eun Bryant to have and to hold
the said tract and parcel of Land and premises with its appurtenances with the said Eliza Bryant and
her heirs forever to the intent proper use and behoef of her the said Eliza Bryant and the said Eun
Bryant for herself her heirs and assigns forever as her man and wife defend the title of the same and
enforce the same against all and every person or persons whatsoever In witness whereof I have hereunto set my
