This Indenture made and entered into on this 21st day of June in the year of our Lord one thousand eight hundred and twenty five between Joseph T. Soper of the first part and James Morris of the second part and Jacob Barnes of the third part all the before named parties of the County of Southampton in the State of Virginia Whereas the said Joseph T. Soper has duly and lawfully sold to the said Jacob Barnes in the sum of ten thousand and twelve dollars and sixpence by two being in date with this Indenture payable on demand the purchase of what together with the interest which shall accrue thereon the said Joseph T. Soper being willing and desirous effectually to give and secure to the said Jacob Barnes of or. Therefore this Indenture witnesseth that the said Joseph T. Soper as well on and on behalf of the premises as of the sum of one dollar current money of the United States to him in hand paid by the said James Morris at or before the execution and delivery of these presents the full receipt whereof is hereby acknowledged and from every part of which the said James Morris and all his legal representatives are forever exonerated and discharged have granted bargain and sold and do hereby grant bargain and sell unto the said James Morris his heirs and assigns as follows that is to say the said Joseph T. Soper have granted bargain and sold and do hereby grant bargain and sell unto the said James Morris his heirs and assigns all the right title interest and Estate which he the said Joseph T. Soper have in and to the following named and described Property to wit the negro woman named Sarah or negro man named Harry One boy named Drew One negro girl named Charlotte and buy these one Sarah above to have and to hold the four above named negroes slaves named Sarah Harry Drew and Charlotte and the buy these one Sarah above named as aforesaid and also to give and to give the appurtenances to the said negroes and houses in any manner belonging and also the right title interest and Estate whatsoever of them the said Joseph T. Soper of or and to the said James Morris the said James Morris do hereby admit and assigns forever to the only proper use and behoof of him the said James Morris his heirs heirs administration and assigns forever for and to the said Joseph T. Soper his heirs heirs administration and assigns shall well and truly pay to the said Jacob Barnes his heirs heirs administration and assigns the aforesaid sum of ten thousand and twelve dollars and sixpence with the interest which shall have accrued thereon and also extending this Indenture in its execution that then this Indenture and every thing therein contained shall be void and of none effect but if the said Joseph T. Soper or any of his heirs heirs administration and assigns shall or shall not pay the aforesaid debt interest and costs as aforesaid at or before therein long required by the said Jacob Barnes his heirs heirs administration and assigns that then upon the request in writing of the said Jacob Barnes his heirs heirs administration and assigns
