This Indenture made and entered into on this 25th day of June in the year of our Lord one thousand eight hundred and twenty five between Joseph G Sayper of the first part and Lewis Morris of the second part and Jacob Barnes of the third part all the before named parties of the County of Southampton in the state of Virginia Whereas the said Joseph G Sayper (hereinafter called) is indebted to the said Jacob Barnes in the sum of ten thousand and thousand dollars and fifty five cents by him bearing over date with this Indenture payable on demand the payment of which together with the interest which shall accrue thereon the said Joseph G Sayper being willing and desirous effectually to give and deliver to the said Jacob Barnes etc. therefore this Indenture witnesseth that the said Joseph G Sayper as well in consideration of the premises as of the sum of one dollar current money of the United States to him in hand paid by the said Lewis Morris at or before the making and delivery of these presents the full receipt whereof is fully acknowledged and from every part of which the said Lewis Morris and all his legal representatives are forever exonerated and discharged here granted bargained and sold and do hereby grant bargain and sell unto the said Lewis Morris his heirs and assigns as appears as follows that is to say the said Joseph G Sayper has granted bargained and sold and do hereby grant bargain and sell unto the said Lewis Morris his heirs and assigns all the right title interest and Estate which he the said Joseph G Sayper have in and to the following named and described Property to wit the Negro woman named Patsy the negro man named Harry one boy named Tom the negro girl named Charlotte and two buggies one sorrel colored to have and to hold the four above named negroes named Slaves named Patsy Harry Tom and Charlotte and the buggies and horses named as aforesaid and all the rights and appurtenances to the said negroes and horses in any manner belonging and all the right title interest and Estate whatsoever of them the said Joseph G Sayper of or and to the same to him the said Lewis Morris his heirs Execs adm^t and assigns forever to the only proper use and beholder of them the said Lewis Morris his heirs Execs adm^t are assigns forever for trust notwithstanding of the the said Joseph G Sayper his Execs or adm^t shall make and truly pay to the said Jacob Barnes his Execs adm^t the aforesaid sum of ten thousand and thousand dollars and fifty five cents together with the interest which shall have accrued thereon and all costs attending this Indenture in its execution that then this Indenture and every thing therein contained shall be void and of none effect but of the said Joseph G Sayper now or for his heirs Execs or adm^t shall or does not pay the aforesaid debt interest and costs as aforesaid at or before thence being required by the said Jacob Barnes his Execs adm^t or assigns that then upon the equity in writing of the said Jacob Barnes his Execs adm^t - pps
