 Foster the receipt whereof is hereby fully acknowledged as full payment and satisfaction not
 bargained for and delivered unto the said James Foster on certain tract or parcel of land
 lying in the County of Southampton and State of aforesaid and being the land and plantation
 whereon James White containing one hundred and forty eight acres more or less and bounded
 by the lands of Abner Scarborough and Abner Smiths Elms to have and to sell the said estate
 and premises unto the said James Foster his heirs Executors adm and assigns forever
 and the said Halsey Foster his heirs Exec and assigns doth by these presents forever warrant and
 defend the right title and interest of the above estate tract or parcel of land and every the
 appurtenances thereto belonging unto the estate of whatsoever simple and the said James
 Foster his heirs and assigns forever in law and equity of the said Halsey Foster both himself and
 his heirs and assigns his heirs and assigns the any and every use claim title
 claim title and demand in person or of
