First Indenture made and entered into this fourteenth day of March in the year of our
Lord one thousand Eight hundred and forty three between Simon Murphy and his wife Lydia
Murphy of the County of Southeaston and State of Virginia on the one part and James Madison
of the same County and State aforesaid of the other part witnesseth for and in consideration of the
sum of fifty dollars lawful money of Virginia to them in hand paid by the said James Madison at
or before the sealing and delivery of these presents the receipt whereof is herby acknowledged They
the said Simon Murphy and Lydia his wife have granted bargained and sold and by these presents doth
grant bargain and sell unto the said James Madison his heirs and assigns forever one certain lot
or parcel of Land and premises lying and being in the town of abovem in the County aforesaid
containing one half acre to the same more or less as being a lot sold to the said Abolition soon after
the said Town was laid off but a due never given thereon and appears on the Map of said Town as
lot No 22 and lying on street Madison the said tract or parcel of Land to have and to hold with
all and every part and parcel thereof unto the said James Madison his heirs and assigns forever
free from the claim or claims of them the said Simon Murphy and Lydia his wife and from all
and every other person or persons whatsoever shall and will ever be out and forever defend by these as
