This Indenture made this 9th day of January in the year of our Lord one thousand eight
hundred and twenty three between Harrison J. Griffin of the County of Southampton and State of Virginia
of the first part John Moore of the same County and State of the second part and Thomas Trotter
of the aforesaid County and State of the third part witnesseth that the said Harrison J. Griffin
doth and in consideration of the sum of one dollar to him or them paid by the said John Moore
at or before the sealing and delivery of these presents the receipt whereof is hereby acknowledged
and as well for the further sum in consideration of the said Harrison J. Griffin being put into
imprison to the said Thomas Trotter on the first and full sum of four hundred and sixty Eight
dollars Two cents lawful money of Virginia and by note bearing date 6th January past which
the said Harrison J. Griffin is willing the more effectually to secure to the said Thomas Trotter
and which is in fact the sole object of these presents hath granted bargained and sold and confirmed and
by these presents doth grant bargain sell Convey and Confirm unto the said John Moore one negro
woman Jenny and her two children Wilson and Madison unto him the said John Moore & his
heirs Executors & Administrators & put upon this special trust and condition that the said John Moore his heirs
Executors or Administrators upon thence being required by the said Thomas Trotter his heirs
Executors Administrators or assigns to make sale of the said negro woman Jenny and her two
children Wilson and Madison at publick auction for the best price that can be obtained
for the same after advertising the same ten days at least at some convenient place on
the neighbourhood or at the Court House of said County and with the money arising from the
sales shall first pay to the said Thomas Trotter the aforesaid sum of four hundred and
sixty eight dollars Two cents with legal interest from date till paid and the cost of selling the same
and then pay the surplus if any to the aforesaid Harrison J. Griffin his heirs or assigns
and the said Harrison J. Griffin for himself his heirs Executors and administrators the title
of the aforesaid negro woman Jenny and her two children Wilson and Madison unto him the
aforesaid John Moore his heirs Executors Administrators and assigns for the purpose aforesaid
mention'd with full warrant and forever defend against the lawful claim or claims
of him the said Harrison J. Griffin his heirs or assigns and all other every other person or
whatsoever and the said John Moore for himself his heirs Executors and administrators
or assigns with covenant and agree to pay back of thence required by the said Thomas Trotter
his heirs or assigns to make sale of the aforesaid negro woman Jenny and her two
children Wilson and Madison at publick auction for the best price that can be had
for the same after advertising the time and place of the sale for any at least fifteen days
and with the money arising therefrom first pay to the aforesaid Thomas Trotter
his heirs Executors and assigns the aforesaid sum mentioned with lawful interest
from date aforesaid until paid and the costs of the sale and the pay the balance
of any to the said Harrison J. Griffin or his assigns and the said Thomas Trotter
