This Indenture made this 9th day of January in the year of our Lord one thousand eight hundred and twenty three between Harriett J. Griffen of the County of Southampton and State of Virginia of the first part John Moore of the same County and State of the second part and Thomas Trotter of the aforesaid County and State of the third part Witnesseth that the said Harriett J. Griffen for and in consideration of the sum of one dollar to him in hand paid by the said John Moore at or before the sealing and delivery of these presents the receipt whereof is hereby acknowledged as well for the further sum in consideration of the said Harriett J. Griffen being indebted to the said Thomas Trotter in the full and full sum of four hundred and sixty eight dollars 75^{cts} complete money of Virginia and by note bearing date 5th January past which for the said Harriett J. Griffen is willing the same effectually to secure to the said Thomas Trotter and which is in fact the sole object of these presents hath granted bargained and sold and confirmed and by these presents doth grant bargain sell convey and confirm unto the said John Moore one negro woman Jerry and her two children Wilson and Abadiah unto him the said John Moore his heirs Executors and assigns upon this special trust and condition that the said John Moore his heirs Executors or administrators upon threats being required by the said Thomas Trotter this heirs Executors administrators or assigns to make sale of the said negro woman Jerry and her two children Wilson and Abadiah at publick auction for the best price that can be obtained for the same after advertising the same ten days at least at some convenient place in the neighbourhood or at the Court House of said County and with the money arising from the sale shall first pay to the said Thomas Trotter the aforesaid sum of four hundred and sixty eight dollars 75^{cts} with legal interest from date here paid and the cost of selling the same and then pay the surplus if any to the aforesaid Harriett J. Griffen his heirs or assigns and the said Harriett J. Griffen forthwith this heirs Executors and administrators the title of the aforesaid negro woman Jerry and her two children Wilson and Abadiah unto him the aforesaid John Moore his heirs Executors administrators and assigns for the purpose aforesaid mentioned with this warrant and forever defend against the lawful claim or claims of him the said Harriett J. Griffen his heirs or assigns and all as every other person or whatsoever and the said John Moore himself his heirs Executors and administrators or assigns with covenant and agree before writing thereto required by the said Thomas Trotter this heirs or assigns to make sale of the aforesaid negro woman Jerry and her two children Wilson and Abadiah at publick auction for the best price that can be had for the same after advertising the same ten days at least at some convenient place in the neighbourhood or at the Court House of said County and with the money arising therefrom first pay to the aforesaid Thomas Trotter this heirs Executors administrators and assigns the aforesaid sum mentioned with lawful interest from date aforesaid until paid and the costs of the sale and then pay the balance if any to the said Harriett J. Griffen or his assigns and the said Thomas Trotter
