 gained and sold and by these presents do bargain and sell unto the said William Dole his heirs and assigns
 a certain parcel of land containing by estimation thirty three and three fourth acres by said survey of the
 County aforesaid and bounded as follows to wit beginning a piece or more corner of said David and Casterphen
 along the path to a cross oak on said path thence said path to a white oak a corner in Benjamin Coffman's line then

 piece a corner of said Braathorn and Dore thence a line of marked trees of said David and Sally to the first station
