 This Indenture made and executed this 27th day of June in the year of our Lord Christ one
 thousand eight hundred and thirty three between Robert Ricks Sen^r of the County of Southampton of the
 one part and Robert Ricks Jun^r of the said County of the other part Witnesseth that the said Robert Ricks
 Senior for and in consideration of the love good will and affection which I have and do bear to my son
 the said Robert Ricks Jr as well for and in consideration the sum of one dollar & no more paid by the
 said Robert Ricks Jr to the said Robert Ricks Sr doth give grant bargain sell transfer and convey unto the
 said Robert Ricks Jr and his heirs and assigns a certain tract or parcel of Land lying and being in the County
 of Southampton aforesaid & being the same Land which a certain Francis Hill purchased of Sam^l Calvert
 and Mary his wife Thomas Clement and Abigail his wife and the said Robert Ricks Jr from the said
 Francis Hill as of due bearing date the 2nd day of November 1804 and recorded the 17th day of December following
 and containing by estimation six hundred and twenty acres be the same more or less and bounded as follows
 To wit on the North and North West side by the Globe Land on the East by the Land of John Davis and on the
 South and South East by the Land of Benjamin Branch and the Land of William and the Land of Joseph
 Williams and on the West by the Land of James Belle But which will more fully and at large appear by ex-
 cepts to the said from the said Sam^l Calvert and wife to Francis Hill and the said Thomas Clement
 and wife to Francis Hill which is duly recorded in the County Court of Southampton also the other part or
 parcel of Land lying and being in the County aforesaid known by the Globe Land and containing by estima-
 tion two hundred and seventy acres be the same more or less which was purchased by a certain John Wadde-
 the owners of the part under the act of Assembly authorizing the sale of the Globe Land in the State of Virginia
 and by the said Robert Ricks of the said Wadde- as of due bearing date the 25th day of June 1805 and recorded
 the 15th day of July following in which deed the boundaries of said Land are as follows To wit Beginning at a
 Gum on the South West side of a small branch of the Crosscut Swamp then South 50 20 12 1/2 pds to a black
 oak then N. 80 pds to a red oak then S. by 6 1/4 pds to a small hickory then S. 37 East 70 pds to a
 white oak on the South side of the branch begun upon then North by 5 1/2 pds to a white oak then N. 7 1/2 pds
 to a red oak then N. 17 1/2 pds to a hickory then N. 17 1/2 pds to a hickory then N. 57 1/2 pds to a gum
 the run of the branch begun on and down the narrow course of the run of the said branch to the beginning
 to have and to hold the said two several parts or parcels of Land unto the said Robert Ricks Jr his heirs
 assigns forever notwithstanding the aforesaid deeds and the survey hereunto And which Eight hundred
 and eighty five acres be the same more or less and the said Robert Ricks Jr herewith has been both and ad-
 with his own hand and deed unto the said Robert Ricks Jr the right and title of it and to the said two several
