This Indenture made and entered into on the 17th day of March in the year of our Lord one thousand eight hundred and forty three between John Blom of the County of Southampton and State of Virginia of the one part and Alex. Blom of the same County and State of the other part witnesseth that the said John Blom for and in consideration of the sum of One Hundred and Sixty Dollars current money of this Commonwealth to him lawfully paid by the said Ellick Davis at or before the execution and delivery of these presents the receipt whereof I hereby acknowledge had granted and set over and by these presents do grant bargain & sell unto him the said Ellick Davis and his heirs forever one certain tract or parcel of Land situated lying and lying in the aforesaid County of Southampton and in the Parish of Saint Lukes containing by a late survey 100 acres to be the same more or less and bounded as follows: Beginning at a large rock standing in the fish road or creek made between said John Blom and Ellick Davis in Davis property and thence along said property line S 73° 45' E 18 rods to a large tree pine corner of said Davis property and thence along said property line S 73° 45' W 36 poles thence S 72° 10' 25" rods thence S 73° 45' W 37 rods to a large green pine tree S 55 M 35 rods to a small green pine standing on the state line in Ellick Davis line thence along the line S 73° 45' 25" poles thence S 73° M 38 poles to a small red oak corner of said Ellick Davis in Ellick Davis property and thence along said Davis property line S 73° 45' 12" rods thence S 73° M 35 poles thence S 73° 45' M 13 rods to a large green pine thence S 73° 45' 39" rods to a large green pine of said Davis and Ellick Davis property line thence along said station posts line S 73° M 35 1/2 rods to a large green pine standing on the fish road near said Ellick Davis corner of said Ellick Davis property and a number made between said John Blom and Ellick Davis thence down the fish road S 35 E 15 poles thence S 73° E 26 poles thence S 73° 45 E 32 poles thence S 73° E 45 poles thence S 73° E 44 poles thence S 73° E 44 1/2 poles to the first station together with all right title interest claim or demand of it or to the said tract of land or any two appearing or subsisting belonging to the same and to have the said tract of land and premises with its appurtenances thereunto belonging unto him the said Ellick Davis and his heirs or assigns forever to the only proportion and share of them the said Ellick Davis and in the said John Blom doth for himself his heirs executors or agents warrant and command to have and to hold the same and to affirm the said the day and date first written
