This Indenture made this 6 day of December one thousand eight hundred and twenty three between
Oroniah Brown of the first part and John Widdowood of the second part and Thomas Widdowood of the
third part all of the County of Southampton and State of Virginia Witnesseth that the said Oroniah Brown
by his bond bearing date with the private hands, duly entitled to the said John Widdowood in the
sum of Thirty seven dollars and six thirty Cents and whereas the said Oroniah Brown is
desires to secure the payment of the said sum above mentioned to said John Widdowood
and his heirs and assigns forever Now this Indenture doth witness that the said Oroniah
Brown hath for and in consideration of the sum of One dollar to him on hand paid by the said
Thomas Widdowood hath granted bargained and sold and by these presents doth grant bargain and
sell unto the said Thomas Widdowood his heirs and assigns forever to wit an Bay from George
Randall Co the said property or now in Southampton and at the said Plains known to have and
belong to the said Oroniah Brown and the said Thomas Widdowood has been and assigns forever
upon the Special Trust and Confidence and for no other purpose or intent that it is long should the
said Oroniah Brown has been and assigns forever to pay the above mentioned debt, which debt it
may be law full and it is hereby declared to be so that the said Thomas Widdowood his heirs and
assigns may and shall by just giving twenty days previous notice of the same at several
places so as good notice may be given at the same to deliver so much of the above mentioned
property as shall be sufficient to pay and satisfy the said for ready money and out of such
sale to make pay to the said John Widdowood his heirs or assigns the sum and interest due the
Costs of carrying of this Indenture into effect and if any surplus money pay to
Oroniah Brown and the said Oroniah Brown doth for himself his heirs and assigns
warrant and defend the title of the before mentioned property to the said Thomas Widdowood
and to his heirs and assigns forever for the Special purposes herein before mentioned
In Witness whereof the said Oroniah Brown John Widdowood and Thomas Widdowood have hereunto set their
hands and seals this 6 day of December 1823

an debtor of the first part and James B. Melton one of the second part and William Melton the son of
of the third part whereas the said Jack Randall party entitled unto the said William Melton and son of
Twenty five dollars and twenty five Cents due by note or account bearing date the 14 February 1824 which
debt and the legal interest thereon the said Jack Randall is willing and desires to secure for the benefit
of himself that he and in consideration of the premises and also for the further consideration of the sum of one
dollar to the said Jack Randall is hereby paid by the said James B. Melton when before the
summing and delivery of these presents the receipt whereof is hereby acknowledged to the said Jack
Randall that given granted bargained and sold and conveyed and confirmed to the said
James B. Melton and son B. Melton his heirs and assigns forever the said property
