This Ordinance made and ordered out on this 25th day of October in the year of our Lord one thousand Eight hundred and twenty four by and between Jacob Williams of the first part and County of the second part and
Sarah Barnes of the third part each of us the above named parties hereinafter in the County of Southampton & State of
Virginia between the said Jacob Williams stands jointly indebted to the said Sarah Barnes in the sum of eight
hundred dollars by bond bearing date until the Substitution payable on demand the payment of which together with
the interest which shall accrue thereon the said Jacob Williams are holding and desirous effectually to agree
unto to have the said Sarah Barnes. Wherefore this Ordinance contains fulls that the said Jacob Williams
as well in consideration of the pecuniary as of the sum of one dozen pounds money of the same stated to him and
paid by the said Matt. Calvert above before the sealing and delivery of these presents the full receipt
whereof is hereby acknowledged and from every part of which the said estate Calvert and all his legal representors
are given released enclimated and discharge have granted bargained and sold and do hereby grant bargain
and sell unto the said Matt. Calvert his heirs and assigns as follows that is to say the said Jacob Williams and
have granted bargained and sold and do hereby grant bargain and sell unto the said estate Calvert his heirs
and assigns all the land or estate which he the said Jacob Williams acquired title to at and by the death of
William Williams his father to set on file and equal share part of all said decedent's lands two hundred
acres and being in the aforesaid County of Southampton bounded on the bounds of the following
named persons to wit Davis Howell Denny Bryant Williams Vick William Barnes George Whistler and
Matthew Barrett furthermore the said Jacob Williams do hereby grant bargain and sell unto the said estate Calvert
his heirs and assigns all his right title interest and claim to a certain tract or parcel of Land which he the said Jacob
Williams purchased of Matt. Williams and being the wife by said bearing date the 15th day of October in the year of our Lord
one thousand eight hundred and twenty four being in the said part of all the Lands of Nathan Williams deceased which the said Matt.
Williams acquired by the death of his father the said Nathan Williams and bounded by the bounds of the above
and certain other lands Howell Denny Bryant William Vick William Barnes George Whistler and
Matthew Barrett furthermore the said Jacob Williams do hereby grant bargain and sell unto the said estate Calvert
his heirs and assigns the following manner paying to the said Sarah Barnes his heirs and assigns
and under pay on Saddle and bridle and fur clothing pieces to have and to hold the said two lots or parcels
of Land together with the above named personal estate with all and singularly the appurtenances thereto belonging
in any manner whatsoever and all the right title interest and estate whatever of him the said Jacob Williams
be it and to the same and every part thereof unto have the said estate Calvert his heirs executors administrators
and assigns forever to the only person or persons holding of him the said Matt. Calvert his heirs executors
administrators and assigns forever. The Trust Mortality that of the said Jacob Williams his heirs
executors and administrators shall well and truly pay to the said Sarah Barnes his executors administrators
and assigns the aforesaid sum of Eight hundred Dollars with the interest which shall have accrued thereon in Eight
years and Jacob Barnes his executors administrators or assigns shall or may require the payment of the above named
sum and Interest which may then accrue thereon that then this Indenture and every thing herein contained
to be void and of no effect but of the said Jacob Williams his heirs executors or assigns shall not pay
to sum of Eight hundred Dollars with the interest which shall have accrued thereon together with the interest which
shall have accrued thereon together with the cost of removing the Indenture on a before the time the said Jacob
Barnes his heirs executors administrators or assigns may or shall require the same upon the request or making entry
of the said Jacob Barnes his executors administrators or assigns or the said Jacob Williams his heirs executors or assigns
the said Matt. Calvert shall and may sell all the real and personal estate hereby contained to him or to such
as may be required to satisfy the aforesaid debt interest and cost of removing and carrying over effect this Indenture
4. Sixth Article For ready money at the place, rates and times by the name of Tony Price going at least forty
days previous publication notice of the time and place of such sale by advertisement posted up on at least three publick
places in the said County of Southampton and that the proceeds of such sale after paying dues and costs of all
debt as aforesaid to be applied by the said Matt. Calvert to the discharge of the aforesaid debt and interest
due and owing to the said Jacob Barnes as aforesaid or so much thereof as may then be due and outstanding the
same as appears and any surplus money thereafter remaining on the hands of the said Matt. Calvert
to his heirs or to the said Jacob Williams his heirs executors administrators or to any part of the said Land
or personal estate Barnes leaving them unapaid at the time of the payment of the aforesaid sum of
money and interest the said Matt. Calvert shall release to the said Jacob Williams all the aforesaid
