Samuel deceased which died last date the 18<sup>th</sup> day of August 1813 and acknowledge and recorded at a Court held for Southampton County on the day even with the date hereof all of which evidence fully off record large appear references being had unto the records of the County Court of Southampton together with One negro woman named Hannah one hand man his duck boy child one pair of Carb whale and two scissars Chars with all and singular the Pictures, painted buildings yards, garden wages waters works, Courts, privileges, profits, emoluments, Commodities, advantages, Entailments, Incidents & appendencies whatsoever to the said lands, pieces or parcels of Land belonging or in any wise appertaining or annexed thereto used and enjoyed or adopted, reputed taken or known as part, parcel, or member thereof and the Novation and remission, Remander and Remandees jointly and other parts of personalty before  
 thereof and every part and parcel thereof with all the title rights and interest are held by the Plaintiff and demand whatever of the said Jeph. D. Neal of me and to the said negro Slave as Chattel Estate appears. To have and to hold the said lands, pieces or parcels of Land with the same onto these depositions And All and Singular other the premises herein before mentioned or intended to be mentioned hargan and dies and every part and parcel thereof together with the aforesaid negro Slave and Chattel property apportioned with every of their right members and appendencies unto the said Garrett Justins his heirs and assigns forever. Subject notwithstanding and this Indenture except the express Condition that to the said Samuel Justins his executors or adm'rs at any time after the first day of January next ensuing the date of these presents when they the said Elliott & Edgar Whitehead or either of them their or either of their heirs executors or administrators shall sell and dispose of the said lands, pieces or parcels of land hereby conveyed and also the negro Slave and Chattel property which may be necessary for ready money at Publick Auction to the highest bidder before the Court House door in the town of Southampton after giving ten days notice of the time and place of sale by advertisement posted up at divers publick places in the said County and shall duly convey the same to the purchaser or purchasers above named in fee simple by sufficient and legal appearance as are stated on this the said Elliott & Edgar Whitehead or either of them their heirs executors or adm'rs that he the said Samuel Justins his executors or adm'rs out of the proceeds of such sale of they shall suffice that he and satisfy unto them the said Elliott & Edgar Whitehead slave shall be sold to him executors or adm'rs of the aforesaid sum of Six hundred dollars with any interest which may accrue from the date of these presents until paid and also pay all expenses attending on such sale of Conveyance and to the said Jeph. D. Neal for himself his heirs executors and adm'rs such Party Covenant and agrees to and with them said Elliott & Edgar Whitehead their heirs executors or adm'rs that he the said Jeph. D. Neal his heirs executors or adm'rs will pay and satisfy unto them the said Elliott & Edgar Whitehead their heirs executors or adm'rs the sum of Two hundred dollars on or before the first day of January next ensuing the date of these presents with all interest due thereon Conveying from the date of these presents until paid as aforesaid mentioned and the said Samuel Justins for himself and his heirs executors and adm'rs such Party Covenant and agrees to and with the said Jeph. D. Neal his heirs executors and adm'rs that he the said Samuel Justins has no his executors or adm'rs will sell the said lands, pieces or parcels of Land with the appendencies hereby conveyed nor any part thereof nor the said negro Slave, Elliott or any part thereof but on the request of them the said Elliott and Edgar Whitehead or either of them their heirs executors or adm'rs are then but on the amount herein before described and that to the said Elliott & Edgar his executors and adm'rs appropriate the proceeds of such sale in manner herein before aforesaid and after satisfying and paying the said several items of money herein before mentioned with any interest that may be due thereon should a balance remain in his or their hands that to the said Elliott & Edgar his executors and adm'rs will sell the same unto the said Jeph. D. Neal his heirs executors or adm'rs at a price of truly pay and satisfy the same unto the said Jeph. D. Neal his heirs executors or adm'rs and the said Garrett Justins his heirs executors and adm'rs such Party Covenant by agree to and with them the said Elliott and Edgar Whitehead their heirs executors or adm'rs that he the said Garrett Justins his executors or adm'rs will sell the same unto the said Jeph. D. Neal his heirs executors or adm'rs.
