 or assigns of the proceeds of such sale of they shall suffer sale with and fully pay unto them the
 said Elliott & Edgar Whitehead their heirs executors or assigns the aforesaid sum of Ten hundred
 dollars or any part which may be due and not paid with any interest which may accrue thereon
 from the date of these presents after satisfying the Charges thereof and all other Expenses attending the
 Execution of this Indenture mentioned as aforesaid, And in further that should such sale shall be
 made it shall be lawful to and for the said Joseph D'Neal his heirs executors or assigns to take and
 use the said granted premises and appurtenances belonging thereto and also the said negro Slave
 and Chattel property and to hold and receive the said issues and profits of the said Lands premises
 and Part of the said negro Slave and use of the Chattel property aforesaid to his own proper
 use and benefit that in case of a sale thereof for the purposes aforesaid to the said Joseph D'
 Neal his heirs executors or assigns shall freely & quietly tender deliver up the said Lands parcel
 or parcel of Land and persons and negro Slave and other property and do all such acts and
 things and deal and lawfully execute all such deeds or other writings as may or shall be of
 him or either of them required for putting the purchaser or purchasers of the said Land negro Slave
 and other property in actual possession of the same And for securing And conforming to such
 purchaser or purchasers their heirs and assigns and to each of them a good true perfect and
 absolute Estate therein and also that the said Joseph D'Neal his heirs executors or assigns do discharge
 all taxes impositions and assessments and other Charges whatsoever or which may or shall be
 payable for the said Land and premises with their appurtenances and also the said negro
 Slave each other property that may be or shall become chargeable thereon during his or their
 possession thereof And the said Joseph D'Neal for himself or his heirs do hereby Covenant
 and agree to and with the him the said Joseph D'Neal his heirs executors or assigns that the
 said Joseph D'Neal and his heirs all and singular the aforesaid lands appurtenances with
 their appurtenances and negro Slave and other property against the Claim or Claim of
 Demand or Demands of them the said Joseph D'Neal and his heirs and against the
 Claim or Claims demand or demands of all and every person or persons whatsoever in the
