of the one part and Elizy Joyner of the other part witnesseth that the said Fabius Knopf doth acknowledge
of the sum of five dollars lawful money of the Commonwealth to herein hand paid by the said Elizy
Joyner at or before the concluding and delivery of this present the receipt whereof is hereby acknowledged
elizy Joyner and paid and by these presents doth bargained and sold unto the said Elizy Joyner
the said and a certain tract of Land containing one hundred and fifty acres more or less
as per the Bonds of the said Elizy Joyner Samuel Turner Anna Johnson and Ephraim Knopf
together with all and singular the appurtenances and the said premises and herreman against
and remainders yearly and other rents of fees and profits thereof and of every part of said
tract with every of her rights members and appurtenances unto the said Elizy Joyner his heirs
and assigns during any natural life of the said Fabius Knopf herself and her heirs
the sum of one hundred and fifty acres of land more or less with all and singular the premises
