 two cows and pigs his feather bed and furniture in general one deal chest with all
 and Procurer the aforesaid to the said parcels of Land belonging or in any way annexed
 to them and all the whole right and title and interest of the said Mark Drake his heirs
 affirms in and to the said granted tract or parcels of Land and premises to have and to
