 that the said Thomas Jordan is To have and to hold the said granted and bargained Premises
 with all the Appurtenances, Previlages & Commodities to the same belonging or in any wise
 appertaining to him the said Thomas Jordan his Heirs & assigns forever to his and their only proper
 use benefit and behoof forever and I the said John Little for me my Heirs Executors & Admonors
 do Covenant Promise and grant to and with the said Thomas Jordan his Heirs & assigns that
 before the Enfealing hereof I am the true sole and Lawful owner of the above bargained Premises
 and am Lawfully seized and Possessed of the same in mine own proper Right as a good Perfect &
 Absolute Estate of Inheritance and have in my self good Right full Power and Lawful Authority
