Darden This Indenture made the third Day of January in the twenty ninth year of the reign
Cobb of our sovereign Lord George the second by the Grace of God of Great Britain France & Ireland
 King Defender of the Faith &c and in the year of our Lord God one thousand seven hundred &
 fifty six Between Robert Darden of Havremont County of the one Part and Nicholas Cobb
 jun^r & Henry Cobb both of the County of Southampton of the other Part Witnesses that the
 said Robert Darden for and in consideration of the sum of Seventeen Pounds ten Shillings
 Current Money to him in Hand Paid by the said Nicholas Cobb jun^r & Henry Cobb at and
 before the Enrolling & Delivery of these Presents the Receipt whereof the said Robert Darden
 doth hereby acknowledge he the said Robert Darden hath granted bargained and sold Alien
 enfeoff and confirmed and by these Presents doth grant bargain and sell alien enfeoff and
 confirm unto the said Nicholas Cobb jun^r & Henry Cobb their Heirs and Assigns forever two
 hundred & fifty acres of Land be the same more or less lying in the aforesaid County of Southampton
 Part of a Patent granted unto Stephen Darden by Honourable Hugh Drysdale Governor
 for three hundred & fifty acres bearing Date the twenty second Day of February one thousand
 seven hundred and twenty four and the said two hundred and fifty acres boundeth as follow
 eth to wit Beginning at a marked Cypress Standing in the Cypress Swamp near the Galberry
 Bridge thence East North East ^{Course} along a line of marked trees to a gum standing in the Cedar
 Swamp in the Patent course thence up the various courses of the Swamp according to the
 Patent bounds to a live oak standing near the Patent ^{Course} a corner tree of Jacob Darden's line
 thence about west course & along Jacob Darden's line to another live Oak a corner in the
 said Land thence West to a pine standing in a Pond a corner tree thence Northeast to a
 Cypress standing in the Patent course in the Cedar Swamp thence turning up the various
 Courses of the Cedar Swamp to the Cypress Swamp and down the various Courses of the
 Cypress Swamp to the aforesaid Cypress the Beginning for Complement And also all
 trees woods underwoods commons common of Pastures Profits commodities Advantages
 Emoluments and Hereditaments whatsoever to the said Land above mentioned belonging
 or in any wise appertaining or in or upon the same growing happening or arising & also the
 Reversion & Reversions Remainder & Remainders Rents and Services of the said premises &
 every part thereof and also all the Estate Right Title Interest Claim & Demand whatso
 ever of him the said Robert Darden of in or to the same premises and every part thereof
 To have and to hold all and singular the said premises above mentioned and every
 part thereof with the appurtenances unto the said Nicholas Cobb jun^r & Henry Cobb their
 Heirs and Assigns to the only proper use and behoof of them the said Nicholas Cobb jun^r
 Henry Cobb their Heirs and Assigns forever and the said Robert Darden for him and his Heirs
 the said Land with the appurtenances above mentioned and every part thereof against him
 and his Heirs and against all and every other Person & Persons whatsoever the said Nicholas
 Cobb jun^r & Henry Cobb their Heirs and Assigns shall and will warrant and forever ^{defend} by these
 Presents In Witness whereof the said Robert Darden hath hereunto put his Hand and
 forever affixed his Seal the Day and year above Written
