103 This Indenture made this twentyfourth Day of April One thousand seven hundred and fifty six Between Richard Richs of the Parish of Nottoway in the County of Southampton of the one part and Robert Richs of the same place and William Scott of the County of Isle of Wight of the other part Witnesseth that for and in Consideration of the sum of fifty pound Current Money of Virginia to the said Richard Richs in Hand paid by the said Robert Richs & William Scott and or before the sealing and Delivery of these Presents the Receipt where of the said Richard Richs doth hereby acknowledge and thereof acquit & discharge the said Robert Richs and William Scott their Exors & Admors forever by these Presents he the said Richard Richs hath granted sold & delivered and by these Presents doth grant sell and Deliver unto the said Robert Richs and William Scott their Exors Admors & Assigns one Negro Man nam'd Mingo and All the said Richard Richs's Stock of Horses Haggis Cattle and Sheep now on the several Plantations belonging to the said Richard Richs and all his Household Furniture and Goods in his Store and all other the Goods & Chattels of the said Richard Richs whatsoever or whereforever being a more particular Account thereof being contained in a certain Schedule hereto annexed signed by the said Richard Richs and bearing even Date with these Presents To have and to hold the said Negro Mingo and all & singular the said Stock Goods & Chattels above mentioned intended to be hereby sold and expressed in the Schedule hereto annexed unto the said Robert Richs & William Scott their Exors Admors & Assigns to their only proper Use & behoof forever And whereas it is necessary for the Collecting & Paying the just Debts of the said Richard Richs to appoint some Person or Persons as his Attorney for the Purpose Know all Men by these Presents that I the said Richard Richs have placed Ordained Constituted and appointed and by these Presents do place Ordain Constitute & appoint in my Name & stead But Robert Richs & William Scott above mentioned my true and Lawful Attornies for me and in my Name to demand ask for and Recover by any legal Waies or Means they shall think necessary all Sums of Money dues Debts & Demands now due owing to me from any Person whatsoever & on Refusal for Payments to commence Actions & Suits for Recovering the same and on Payment sufficient Discharges & Releases to give in my
