 and my self therewith fully satisfied & contented & thereof and of every
 thereof do acquit and discharge the said Timothy Thorpe his Heirs Executors and
 by these presents have given granted bargained sold aliened conveyed
 by these Presents do freely fully and absolutely give grant bargain sell a
 unto the said Timothy Thorpe his Heirs and assigns forever one Certain Tract & Part
 Situate lying and being in the County of Southampton on the North Side of the Three Creeks
 as followeth to wit Beginning at a poplar on the South side of Blowman's Swamp thence
 West one hundred & three Poles to a red oak thence North eighty Degrees west one hun
 dred Pole to a pine thence North ten Degrees East fifty five Pole to a gum by the side
 Branch then Down the various Courses of the Run of the said Branch to Blowman's Swamp as
 and Down the various Courses of the Run of the said Swamp to the beginning To have and to he
 the said Granted & bargained Premises with all the Appurtenances Privileges & Commodities to the
