therefrom doth fully acquit & Discharge the said W^m Cooper his Heirs & Assigns for ever With
Bargained sold Aliened Enfeoffed and Confirmed and by these Presents doth give Grant Bargain and
sell unto the said W^m Cooper one Certain Tract or parcel of Land Containing One Acre more or less lying
being on the South side Nettoway River it being Part of a Tract of Land granted to John Vaper dated
June the sixteen One thousand Seven hundred & twentyseven and Bounded as followeth 1st with Beginning
at a Hickory on the side of the River thence Westward to a Beach on the S. River again thence Down the
Meanders of the said River to the first station with all Woods underwoods ways Waters Swamps Marshes
Low Grounds Meadows feedings together with and singular the appurtenances whatsoever thereunto
