Back line running along the said line North forty five Degrees East one hundred and
seventy four poles to a Hickory in the said line thence North forty five Degrees West
two hundred & forty poles to a pine south forty five Degrees West one hundred &
seventy four poles to another pine & south forty five Degrees East two hundred &
forty poles to the Beginning Now this Indenture Witnesseth that the
said chief Men of the said Indian Nation with the consent & Approbation of the said Trustees
Testified by their being made parties to these pres. for and in consideration of the
said sum of forty four pounds ten shill. Secured to be paid as Aforesaid Have
granted Bargained & sold aliened enfeoffed Released & confirmed & by these presents do
grant Bargain & sell alien enfeoff release and confirm unto the said William Pope
his Heirs and Assigns the said two hundred and sixty one Acres part of the said Tract
of five thousand Acres of Land as above to be sold & also the Reversion and Reversions
Remainder & remainders Rents & Services thereof & also all the Estate Right Title
Interest Property claim and Demand whatsoever of the said Nation & their Possessors of in
and to the same To have & to hold the said two hundred and sixty one Acres of Land with
