

Road to the eastern & southern Boundary thereof Containing about five thousand
 Acres for the best price that could be got & after any Agreement made for the sale of the
 same or any part thereof it is by the ^d Act declared lawfull for the chief men of the
 Nation together with the Trustees afores^d or the survivors or Survivor of them to seal
 & Deliver any Deed or Deeds indented for the conveyance of the feesimple Inheritance
 of the ^d Lands to the purchaser upon his entering into bond with good security for the
 paymt^t of the purchase Money to the ^d Trustees for the use & purposes in the ^d Act
 expressed & whereas the ^d William Turner for the consideration of fifty one pounds
 Curr^t Money (for the paymt^t whereof to the ^d Trustees for the use afores^d he hath entered
 into Bond with good security) hath purchased three Hundred & sixty four Acres part of
 the ^d Tract of five thousand Acres of Land of the ^d chief men of the ^d Indian Nation with
 the Consent and Approbation of the ^d Trustees Bounded as followeth to wit Beginning
 at a Maple a corner of Number three on the West side of Duckhorn swamp in the Edge
 of the low grounds & at the Mouth of the bridge Branch running up the Meanders of the
 said Branch to a small pine in the Branch thence along a line of Marked Trees south
 three Degrees east one hundred poles to a pine on Barrows Road thence up the said
 Road to a black Jack a corner on the Road side North ten Degrees West three hundred &
 eighteen poles to a white Oak in the Edge of Duckhorn swamp afores^d and down by the
 Edge of the low grounds of the ^d swamp to the Beginning now this Indenture
 Witnesseth that the said Chief men of the ^d Indian Nation with the Consent and
 Approbation of the ^d Trustees testified by their being made Parties to these presents
 for & in consideration of the ^d Sum of fifty one pounds Secured to be paid as afores^d
 Have granted Bargained & sold aliened enfranchised Released & confirmed & by these
 presents Do grant Bargain & sell Alien enfranchise release & Confirm unto the said
 W^m Turner his Heirs and Assigns the ^d three hundred & sixty four Acres part of the ^d
 Tract of five thousand Acres of Land as above to be sold & also the Reversion & Reversions
 Remainders & Remainders Rent & Services thereof & also all the Estate Right Title
 Interest Property Claims & Demand whatsoever of the ^d Nation & their Posterity
 of in & to the same to have & to hold the ^d three hundred & sixty four Acres of
 Land with the Appurtenances unto the ^d William Turner his Heirs & Assigns to
 the only proper use & behoof of the ^d W^m Turner his Heirs & Assigns forever
 In witness whereof the ^d Chiefs & Trustees have hereunto set their Hands and
 affixed their seals the Day & year first above written.
