This Indenture made this Thirteenth Day of April In the year of our Lord Christ One thousand seven Hundred & Fifty seven Between Aaron Thorpe of the County of Southampton Planter of the One part And Abraham Johnson of the same place Planter of the Other part Witnesseth that these Aaron Thorpe for & in Consideration of the sum of Twelve pound Current Money of King to him in hand paid before the envealing & Delivery hereof the Receipt whereof he doth hereby acknowledge himself therewith fully Contented satisfied & paid of thereof and therefrom doth hereby fully Acquitt & Discharge these Abraham Johnson his Heirs Executors & Assigns by these presents Hath given granted Bargained sold Aliened Enfeoffed & confirmed & by these presents doth fully freely & Absolutely give grant Bargain sell Alien Enfeoff & confirm unto these Abraham Johnson his Heirs & Assigns One Certain Tract or Parcel of Land containing by Estimation One Hundred Acres be the same more or less lying & being in the County of Southampton lying on the Northside of Pusells Branch Beginning at the fork of the main Branch as a White Oak a Corner Tree then to Another white Oak a Corner Tree then to a pond at the Head of a small Branch & then up the fork Branch to the head With all woods Water
