Between David Newsom of the County of Southampton & Parish of Nettonway of the One part being
Barham of the Aforesaid County & Parish of the Other Part Witnesseth that for & in consideration
of the sum of Five pounds Current money of Silver to the said David Newsom in hand paid by the said
Benj^r Barham as or before the Enrolling & Delivery of these presents the Receipt whereof the said David

Bargained Sold Alien Released & confirmed & by these presents doth Grant Bargain Sell Alien
