Blunt Know all men by these presents that Priscilla Blunt of Southampton County
to Am held and firmly bound unto Alexander Watson of the County aforesaid his heirs Executors
Watson Administrators or assigns in the full and Just Sum of Twenty Pounds Currant Money of
Virginia to which Payment well and truly to be made and Done I Bind myself my heirs
Executors and Administrators firmly by these presents sealed with my Seal and Dated this
thirteenth Day of October Anno Domini 1757

The Condition of the above Obligation is such that Whereas the above Bounden Priscilla
Blunt hath this present Day purchased of the above named Alexander Watson the Land
and plantation whereon the said Alexander Watson now lives for the Consideration
Sum of Twenty five pounds Currant Money of Virginia fifteen pounds thereof paid
Down. and the Remaining ten pounds to be paid Immediately after the Decease of Sarah
the wife of the said Alexander Watson and the said Alexander Watson is to have the
use of the said Land plantation and Houses to dwell upon and occupy the same not
employing more than one hand at any time more than his present force for and
during the life of his said wife Sarah on his due paying the Duties and Taxes
thereof and keeping the plantation and Houses in good repair and not cutting nor
destroying any such or more timber on the said Land than what is necessary and
convenient for the plantation use. Nevertheless the said Priscilla Blunt for herself her
heirs Executors and Administrators Doth hereby agree with the said Alexander Watson
that if he the said Alexander Watson shall at any time before the Death of his said wife
Sarah Surrender up to the said Priscilla Blunt or her heirs the use of the said plantation
and Houses in repair as aforesaid and his said wife Sarah Relinquish her Right of Dower
that thereupon she the said Priscilla Blunt her heirs Executors or Administrators shall
and will Immediately pay to the said Alexander Watson the ten pounds aforesaid Now
if the said Priscilla Blunt her heirs Executors or Administrators shall well and truly
Obide by and perform the above Agreement according to the true Intent and Meaning
of these presents then the above Obligation to be void Else to remain in full force and Virtue.
