This Indenture made this eighth Day of December in the Year of our Lord One thousand seven hundred and fifty seven Between Alexander Murray of the County of Southampton of the one part and Peter Clarke of the County of Middlesex of the other Part Witnesseth that the said Alexander Murray for and in Consideration of the Sum of forty five Pounds Current Money of Virginia to him in Hand paid by the said Peter Clarke the Receipt whereof the said Alexander Murray doth hereby Acknowledge he the said Alexander Murray hath granted bargained and Sold Alien and Confirmed and by these presents Doth Grant bargain and Sell Alien and Confirm unto the said Peter Clarke One certain Tract or Parcel of Land containing two hundred and fifty Acres situate lying and being in the County of Southampton the said Tract or Parcel of Land being Part of a Patent granted to Edward Harris for 250 Acres Land bearing Date . . . and bounded as follows Beginning at the Mouth Brushy Branch thence up the said Branch to a White Oak a Corner Tree of William Allens Land Thence to Benjamin Cochs Line thence along Cochs Line to John Griffins Corner Red Oak thence along the said Line to Warwick Branch to a Line thence down the said Branch to the Beginning The Reversion and Reversions Remainder and Remainders Rents and Services of the said Premises and of every Part thereof and also all the Estate Right Title Interest Claim and Demand whatsoever of him the said Alexander Murray of in and to the same Premises and every Part thereof To have and to hold all and singular the same Premises within mentioned and every Part and Parcel thereof with the Appurtenances unto the said Peter Clarke his Heirs & Assigns to the only proper Use and behoof of the said Peter Clarke his Heirs and Assigns for ever and the said Alexander Murray for himself his Heirs the said Land and Premises and every Part thereof against him and his Heirs and against all and every other Person and persons whatsoever shall and will Warrant and for ever Depend unto the said Peter Clarke his Heirs and Assigns forever In Witness whereof the said Alexander Murray hath hereunto set his Hand and affixed his Seal the Day & Year above Written
