This Indenture made the 9th Day of February in the Year of our Lord one Thousand seven hundred and fifty eight Between Robert Newsum of the County of Southampton of the one Part and Benjamin Newsum of the said County of the other Part Witnesseth that the said Robert Newsum for and in Consideration of the sum of five Shillings current Money of Virginia to him in Hand paid by the said Benjamin Newsum the Receipt whereof the said Robert Newsum doth hereby acknowledge hath granted bargained and sold aliened conveyed and confirmed and by these Presents doth grant bargain and sell alien convey and confirm unto the said Benjamin Newsum his Heir and Assigns forever one certain Tract or Parcel of Land lying and being in the County aforesaid containing by Estimation two hundred Acres the same being more or less and bounded as followeth to wit Beginning at a Line by the Side of the ready Branch then South twenty nine Degrees East sixty two Poles to a lightwood Post in Benjamin Faircloth's Line then by the said Faircloth's Line East sixty six Poles to two Lines thence North fifty three Degrees East to a Line a Corner Tree made in the Survey then by a Line of marked Trees crossing the Survey to a Pine a Corner Tree in Joseph Newsum's Line then by the said Joseph Newsum's to a Pine in William Edwards Line then by the said Edwards Line to a live Oak by the Side of the Ready Branch aforesaid then up the Run of the said Branch to the Beginning with all Trees Woods Underwoods Commons Common of Pastures Profits Commodities Advantages Emblements Tenements Whatsoever to the Plantation or Tract of Land belonging or in anywise appertaining or upon the same growing happening or arising and also the Curfew Reversions Remainder and Remainders Rents Services of the Premises and every Part thereof and also all the Estate Right Title Interest Claim and Demand whatsoever of him the said Robert Newsum of in or to the same Premises and every Part thereof To have and to hold all and singular the said Premises abovementioned and every Part and Parcel thereof with the Appurtenances unto the said Benjamin Newsum his Heir and Assigns to the only proper Use and Profit of him the said Benjamin Newsum his Heir and Assigns forever and the said Robert Newsum for himself and his Heir the said Plantation and Premises and every Part thereof against him and his Heir and against all and every other Person and Persons whatsoever unto the said Benjamin Newsum his Heir and Assigns shall and will Warrant and forever Defend by these Presents In Witness whereof the said Robert Newsum hath hereunto set his Hand and affixed his Seal this Day and Year above written
