This Indenture made the fourteenth Day of December in the thirty second year of  
the Reign of our Sovereign Lord George the second and in the Year of our Lord Christ one thousand  
Seven Hundred and fifty Eight Between Job Wright of Nethoway Parish in Southampton  
in Virginia of the one part and Joseph Vick of the County and Colony aforesaid of the other part  
Witnesseth that the said Job Wright for and in consideration of the sum of five Pounds  
Current Money of Virginia to him in Hand paid by said Joseph Vick also before the  
Enrolling and Delivery of the presents the Receipt of whereof the said Job Wright Doth hereby  
acknowledge he the said Job Wright hath Granted Bargained and sold Alien'd Enfeoffed and confirmed  
and by these presents Doth Grant Bargain and sell Alien Enfeoff and Confirm unto the  
said Joseph Vick his heirs and Assigns forever a Certain Tract or Parcel of Land  
Containing one Hundred and twenty Acre be the same more or less Situated Lying &  
being in the Parish and County aforesaid it being part of a Patent of Two hundred and  
Seventy Acre Granted to and for the thirteenth Day of November one thousand Seven  
Hundred and thirtion and Bounded as followeth Viz. Beginning at a pine corner  
Tree standing in a Branch Called the Feather Bed Branch wch the various course of  
the Run of the said Branch to a Live Oak standing in the Head of the said Branch from thence  
a straight Line of marked Trees to a white Oak standing in Benj. Beels Line making a Corner  
from thence along the said Beels Line to a white Oak corner Tree of Type Jeyners Line from  
thence along the said Jeyners Line to Joseph Vicks Line and from thence along the said  
Vicks Line to a white Oak corner Tree of Job Wrights Line and from thence along the  
said Wrights Line to the first Station the said Land Redawning to William Newson &  
his heirs at Law to the Patent and by him conveyed to the said Job Wright by Deed bearing  
Date the nineteenth Day of October 1758 and also all Trees and underwood Commons  
Common of pastureage Profits Commodities Advantages Emoluments and Accretions what  
soever to the said Land above mentioned Belonging or in any wise appertaining or in or  
upon the same Growing happening or arising and also the Reversion and Reversions  
thereof and also the Estate Right Title and Interest Claim and Demand whatsoever  
of them the said Job Wright of in or to the same premises and Every part thereof
