This Indenture made this Twelfth day of November in the year of our Lord Christ one Thousand seven Hundred & fifty eight between Edward Windham of Southampton County in Virginia of the one part & Benjamin Davis of the County aforesaid of the other part It is to be remembered that the said Edward Windham for & in consideration of the sum of Fifty eight pounds Current money of Virginia to him in hand paid by the said Benjamin Davis at & before the in sealing & delivery hereof the Receipt whereof the said Edward Windham doth hereby acknowledge & therof doth acquit the said Benjamin Davis his heirs Executors & Administrators hath granted Bargained Sold Alien Infeoffed confirmed & made over unto the said Benjamin Davis his heirs or Assigns forever & by these presents doth grant bargain sell Alien Infeoff confirmed & make over unto the said Benjamin Davis his heirs & Assigns forever one certain Tract or parcel of Land Situate lying & being in Southampton County aforesaid containing Two hundred & Seventy acres of Land (be the same more or less) Being granted to Frances Sharpes a patent Bearing date the Sixteenth day of June one thousand seven hundred & forty four & Bounded as followeth (to wit) Beginning at a pine by the side of the flat Swamp a corner of Frances Sharpes Land thence by thence by the said Sharpes Old Lines South Twenty degrees West one hundred & sixty poles to a Hickory & North Forty Degrees West one hundred & four poles to a Red oak. & North fifty Degrees West Twenty five poles to a pine & South west forty poles to a pine, then south Thirty five Degrees East ninety eight poles to a black oak. Then South Thirty five Degrees West sixty three poles to a pine Then south twenty five Degrees East one hundred & fifty poles to a red oak sapling then South Eighty Degrees East fifty seven poles to a pine then south Twenty Two Degrees East twenty five poles to a red oak a corner of John Galtneys Land thence by the said Galtneys Line North thirty Degrees East Eighty four poles to a pine & South east Twenty eight poles to a red oak sapling then north Sixty Degrees East Eighteen poles to a red oak by the side of the flat Swamp aforesaid & up the various Courses of the run of the said Swamp to the beginning So have and to hold the said Two hundred & Seventy Acres of Land and all and singular the Improvements & Concomitants
