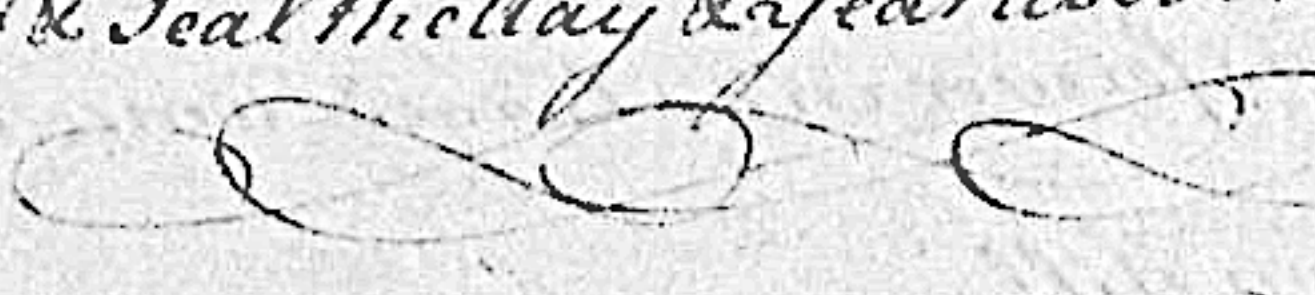


This Indenture made the fourteenth day of February in the year of our
 Lord one thousand seven hundred & sixty Between Arthur Pope of the County of Southampton
 of the one part & Robert Holland of the County of Isleswight of the other part Witnesseth that the
 said Arthur Pope for & in consideration of the sum of seven pounds current money of Virginia so
 him in hand paid by the said Robert Holland, the Receipt whereof he doth hereby acknowledge & that
 the said Arthur Pope hath granted & sold all and confirmed & by these presents do grant bargain
 & sell all and confirm unto the said Robert Holland his heirs & assigns forever two hundred
 & eighty seven acres of Land be the same more or less Lying & being in Southampton County
 & bounded as followeth to wit Beginning at a gum standing in the fork of the Line Branch
 thence South seven Degrees East one hundred poles to a black oak thence South forty poles to a pine
 a fore & aft tree standing in Jacob Simon's Line thence west to a real Joyners Corner Tree
 thence a north east Course to a black jack thence North Sixty degrees East Sixty eight poles to a
 white Oak by a Branch side thence up the said Branch to the Beginning the said Devidend of Land
 is part of two patents of Land granted to Henry Pope & Jacob Simons the said Henry Popes
 patent bearing date the Twentieth Third of March one thousand seven hundred & sixteen & the
 aforesaid Simons patent bearing date the Twelfth day of July one thousand seven hundred &
 fifty & also the Reversion & Reversions Remainder & Remainders Rents & Services of the said Land &
 premises an every part & parcel thereof & all the Estate Right Title Claim Interest & Demand what
 soever of the said Arthur Pope of in & to the said Land & premises & every part thereof to have &
 to hold all & singular the said Land & premises above mentioned & every part & parcel thereof
 with the appurtenances unto the said Robert Holland his heirs & assigns forever & the said Arthur
 Pope for him self his heirs the said Land and premises and every part thereof and against all
 and every other person or persons what soever the said Robert Holland his heirs & assigns
 shall and will warrant and forever Defend by these presents In Witness whereof the said
 Arthur Pope has hereunto set his hand & Seal the day & year above Written
 Signed Sealed & Delivered in presence of  Arthur Pope
