This Indenture made the eighth day of May in the thirty third year of the reign of our Sovereign Lord George the second by the grace of God of Great Britain France & Ireland King Defender of the Faith &c. in the year of our Lord God one Thousand seven hundred & Sixty Between Thomas Barham of the County of Southampton & Parish of Mottoway of the one part & Solomon Deloach of the said County & Parish of the other part Witnesseth that the said Thomas Barham for & in consideration of the sum of eighty pounds current money of Virginia to him in hand paid at or before the Insealing & Delivery of these presents to the receipt of which & himself fully satisfied contented & paid he doth hereby acknowledge have granted Bargained & sold Aliened enfeoffed released & confirmed & by these presents doth give grant Bargain & sell Alien & confirm unto the said Solomon Deloach his heirs & assigns forever a certain Tract or parcel of Land containing one hundred & ninety Acres lying & being in the aforesaid County on the South side of Mottoway River & on the South side of the spring swamp & bounded as by a patent granted to Christopher Robertson bearing Date the Thirtieth day of March one Thousand seven hundred & Sixty Three Relation thereof may more fully appear also all woods under woods way water & water courses & with all profits commodities & advantages what soever to the same belonging or in any wise Appertaining & also the Reversion & Reversions Remainder & Remainders Rent & Services of the said premises & every part thereof & also all the Estate Right Title Interest Claim & Demand what soever of him the said Thomas Barham of in or to the same premises & every part thereof To have & to hold all and singular the said premises above mentioned and every part & parcel thereof with the Appurtenances unto the said Solomon Deloach his heirs & assigns to the only proper use & behoof of the said Solomon Deloach his heirs & assigns forever and the said Thomas Barham for himself his heirs &c. the above mentioned premises & every part thereof against him & his heirs and against
