 & by these presents doth grant bargain sell alien Release & confirm unto the said Nathan Newsum
 his heirs & assigns forever all that plantation Tract or parcel of Land whereon the said Benjn Barham
 now Live Situate Lying & being in the parish & County aforesaid Containing by Estimation Two
 Hundred & Ten Acres be the same more or less fifty Acres thereof being purchased by the said Benjn
 Barham of Stephen Vaughan by Deed Bearing Date the second day of May MDCCXVIII fifty
 Acres thereof being purchased by the said Benjn Barham of Thos Barham by Deed Dated
 the fourth day of May in the year last aforesaid one Hundred Acres other part thereof being purchased by
 the said Benjn Barham of the said Thomas Barham by Deed dated the fourth day of September in the
 year MDCCXVIII & ten Acres the Residue thereof being purchased by the said Benjn Barham of David
