This Indenture made this day of in the Year 1826 by and between Sepe. Parker
 of Southampton County Virginia of the one part and Jacob Darden of the same County and State of
 the other part. Witnesseth that whereas the line now dividing the lands of them the said Sepe. Parker
 from those of the said Jacob Darden which runs between their plantations, which line was agreed
 upon and Established by an interchange of deed executed by and between Jordan Williams the
 former proprietor of the lands and plantation now owned and occupied by the said Sepe
 Parker and the said Jacob Darden each to the other which deed bears date the 12th day of
 November 1814 is still found to be less Convenient than it might be and whereas for the mutual
 benefit and Convenience of each they the said Sepe. Parker and Jacob Darden are willing
 and desirous to alter the said dividing line as to make it still more Convenient to them
 both they the said Sepe. Parker and Jacob Darden for themselves their and each of their
 heirs Executors and assigns have agreed and by these presents do agree to and with each other
 to alter in part the line so as aforesaid established by Jordan Williams and the said Jacob
 Darden in the following manner viz Beginning at a Person more than the third line here on
 corner in the deed interchanged as aforesaid standing on the fence side running thence on the
 direction of the fence southwesterly. thence from said to the corner of the fence thence westward
 along the fence to a sweet gum thence running a little more northerly along the fence
 to a small live oak standing on the fence side thence as the fence now runs to the turn
 of the road leading to Saw. Ferry near where the said Jacob Darden's fence joins to the
 said Sepe. Parker's a stake mentioned in the deed interchanged as aforesaid thence as
 specified in the said deed, which line now ~~is~~ agreed upon and Established as aforesaid
 gives to the said Jacob Darden what is estimated to be two acres of land from the land of
 Sepe. Parker as now laid. Now therefore for and in consideration of the premises aforesaid
 and especially for and in consideration of seven dollars to the said Sepe. Parker in hand paid
 by the said Jacob Darden at and before the executing and delivery of these presents: He
 the said Sepe. Parker for himself his heirs Executors and assigns hath granted bargained sold
 aliened and Confirmed and by these presents doth grant bargain sell alien & Confirm unto him
 the said Jacob Darden his heirs and assigns forever the two tracts of Land aforesaid
 to have and to hold the said two acres of Land with its appurtenances to him the said
 Jacob Darden and to his heirs and assigns forever And he the said Sepe. Parker for
 himself his heirs Executors and assigns doth yield by these presents warrant & defend the said
 bargained premises against the lawful claim or demands of all and every person
 whatsoever to him the said Jacob Darden his heirs and assigns forever
