Thomas Barnes in the sum of One hundred thirty three dollars Bonds bearing Ex. on date with
these presents payable on demand the payment of which together with the interest which shall
accrue thereon the said John M. Whitfield being willing and desirous of effectually to ap-
prove to said Thomas Barnes that therefore this Indenture importeth that the said John M.
Whitfield as well in consideration of the promises as of the sum of One dollar in hand paid
by the said Jacob Barnes at or before the executing & delivery of these presents the full
receipt whereof is hereby acknowledged and from every part of which the said Jacob
Barnes and all his legal representatives are forever Exonerated and discharged have granted
bargained and sold and do hereby grant bargain and sell unto the said Jacob Barnes
his heirs and assigns as follows that is to say the said John M. Whitfield have granted
bargained and sold and do hereby grant bargain and sell unto the said Jacob Barnes
his heirs and assigns all the right title interest and Estate which he the
said John M. Whitfield have in and to 20 acres of land as is supposed lying & being
in the aforesaid County of Southampton and bounded as follows to wit Beginning
