This Indenture made and entered into the 18th day of June in the Year of our Lord
 1826 Between Amos Drury of the first part Henry Leon of the second part and Wilson
 Wellons of the third part all of the County of Southampton and State of Virginia
 Witnesseth that the said Amos Drury for and in consideration of the sum
 fifty nine dollars and 90 cents which sum is due from the said Amos Drury
 to the said Henry Leon by bond bearing date the 16th day of June 1826 as well as
 all other monies which may be due and owing from the said Amos Drury to the
 said Henry Leon by means of any dealings transfer of debts or paper whatsoever make
 for and in consideration of one dollar to him and hand paid by the said Wilson Wellons the
 receipt whereof the said Amos Drury hereby acknowledges he hath granted bargained sold
 and by these presents doth hereby grant bargain and sell convey and make over unto the
 said Wilson Wellons and his heirs forever all his right and interest in the following
 property to wit the plantation where the said Amos Drury now lives containing by value
 then one hundred and sixty acres being the same more or less belonging to the said Amos
 Drury To have and to hold with all the right and interest of the said land him
 conveyed or intended to be conveyed to him the said Wilson Wellons his heirs &
 assigns forever upon ~~that~~ special Trust nevertheless that the said upon being there
 required by the aforesaid Henry Leon shall proceed to sell all the right and end of
 the said Amos Drury to the above named land or plantation hereby conveyed or
 intended to be conveyed after advertising the same and place in the said County of
 Southampton for ten days previous at some publick house or store for cash and out of
 the money arising out of the said sale in the first place pay and satisfy all cost attending
 the said sale as well as the expense attending the said conveyance and then pay off
 the debt aforesaid and with interest as well as all other monies which may appear to be
 due and owing from the said Amos Drury to the said Henry Leon by means of any
 dealings transfer of debts or paper whatever and the surplus if any pay to the said
 Amos Drury and the said Amos Drury for himself heirs executors & assigns the right
 and title of the said property unto the said Wilson Wellons his heirs & assigns
 forever doth hereby warrant and defend against the lawful claim of him the
 said Amos Drury heirs executors & assigns and against all and every other person or
 persons whomsoever and the said Wilson Wellons on his part covenants & agrees
 that he will make sale of the right and interest hereby conveyed for the best price he can
 obtain for the same after advertising the time and place of sale for ten days previous
 at some publick house or store in the said County and with the money arising from the
 sale first pay and satisfy all costs attending the same as well as the expense attending
 this conveyance and then pay off the aforesaid debt and interest as well as all other
 monies which may appear to the said Henry Leon to be justly due & owing
 from the said Amos Drury to the said Henry Leon by means of any dealings transfer of
 debts or paper whatever and then pay off the surplus if any to the said Amos Drury
 and the said Wilson Wellons on his part covenants and agrees that he will release
 the said Amos Drury from the obligation of the indenture upon the said
 Amos Drury paying him the amount of the aforesaid sum of fifty nine dollars & 90
 cents with interest as all other money which may be due and owing to the said Henry
 Leon by means of any dealings transfer of debt or paper whatever
